Thank you for being a part of the MVCS Family! The purpose of this letter is to provide important information about re-enrolling your student(s) for the 2024-2025 academic year. This year, we will be implementing a Continuous Enrollment Contract. Therefore, you will not need to fill out any additional paperwork or sign any additional contracts for re-enrollment. Information and the details on how to complete the continuous contract will come directly to you in the next week from our Admissions Department.

Due to the ability to streamline this process, our registration fee, curriculum fee and activity fee are now combined into one \$750 non refundable enrollment fee. The enrollment fee will be billed to your tuition account in two installments:

- (1) \$375 will be processed on your April 2024 scheduled payment date.
- (2) \$375 will be processed on your June 2024 scheduled payment date.

For our 2024-2025 academic year, our Board of Directors approved the following tuition rates:

- \$7,499 for Elementary School (K-6<sup>th</sup> Grade)
- \$7,999 for Junior High School (7<sup>th</sup>-8<sup>th</sup> Grade)
- \$8,999 for High School (9<sup>th</sup>-12<sup>th</sup> Grade)

Tuition will be billed and paid through FACTS Tuition Management. All families are required to have a FACTS Tuition account and must maintain their account with a valid form of payment while their student is enrolled at the school. Your current payment plan has been rolled over for 2024-25. All families are required to apply for tuition assistance each year.

If you intend to withdraw for the 2024-2025 school year, please complete the withdrawal form prior to March 1, 2024 so that the April 2024 payment does not automatically process on your tuition account.
